

Acceptable use policy for the ASDAN platform

1. This Acceptable Use Policy sets out the terms on which you may use ASDAN's learner platform at equitas.asdan.org.uk ("the Platform"). By accessing or using the Platform, you accept and agree to comply with this Acceptable Use Policy.
2. You may only use the Platform for lawful purposes. You may not use the Platform:
 - 2.1. in any way that breaches any applicable local, national or international law or regulation;
 - 2.2. in any way that is unlawful or fraudulent, or has any unlawful or fraudulent purpose or effect;
 - 2.3. in any way that is malicious, offensive, threatening, defamatory, obscene, harassing, false, misleading or unreliable, or that brings or is likely to bring ASDAN into disrepute;
 - 2.4. for the purpose of harming or attempting to harm minors in any way;
 - 2.5. to send, knowingly receive, upload, download, use or re-use any material which does not comply with this Acceptable Use Policy; or
 - 2.6. to knowingly transmit any data, send or upload any material that contains viruses, trojan horses, worms, time-bombs, keystroke loggers, spyware, adware or any other harmful programs or similar computer code designed to adversely affect the operation of any computer software or hardware.
3. ASDAN does not allow content on the Platform which:
 - 3.1. contains language or imagery which could be deemed offensive or is likely to harass, upset, embarrass, alarm or annoy any other person (including for example and without limitation, language that could be deemed discriminatory towards an individual's race, colour, ethnicity, national origin, religion, disability, sexual orientation, gender expression, gender identity or physical appearance);
 - 3.2. is obscene, pornographic, violent or otherwise may offend human dignity (including for example and without limitation, language that could be deemed discriminatory towards an individual's race, colour, ethnicity, national origin, religion, disability, sexual orientation, gender expression, gender identity or physical appearance);
 - 3.3. is abusive, insulting or threatening, discriminatory or which promotes or encourages racism, sexism, hatred or bigotry (including for example and without limitation, language that could be deemed discriminatory towards an individual's race, colour, ethnicity, national origin, religion, disability, sexual orientation, gender expression, gender identity or physical appearance);
 - 3.4. encourages any illegal activity including, without limitation, terrorism, inciting racial hatred or the submission of which in itself constitutes committing a criminal offence;
 - 3.5. is defamatory or libellous;
 - 3.6. contains any spyware, adware, viruses, corrupt files, worm programs or other malicious code designed to interrupt, damage or limit the functionality of or disrupt any software, hardware,

telecommunications, networks, servers or other equipment, Trojan horse or any other material designed to damage, interfere with, wrongly intercept or expropriate any data or personal information;

- 3.7. itself, or the posting of which, infringes any third party's rights (including, without limitation, intellectual property rights and privacy rights);
- 3.8. is harmful to minors; or
- 3.9. impersonates any other person, including falsely stating your name.
